#### 8. Report on recent National Championships – Chris

Six teams went to junior championships: LCC, ECS, Kuper, Royal West and Loyola. Great time was had by all. No team may go to both Junior and Senior nationals in the same year. Next year Junior Nationals will be in Toronto, ON.

#### 9. Proposal for Provincials - Chris

Significant problems with getting judges on weekdays for provincials. Other provinces do a full, elaborate provincial tournament. Teachers missing multiple school days for both junior and senior provincials. Debaters will have to choose between Junior or Senior, though this is not a big concern.

#### Discussion:

Having only one prepared round at provincials would take away practice that students get for Nationals' two prepared rounds. We could have two prepared rounds if we have 6 rounds total.

**Tournament Format:** Jon proposes we have two prepared rounds Friday night, four bracketed rounds on Saturday. For the first year, do not have final.

**Cap:** Every school may send up to four teams in whatever (senior/junior) combination and send more if space remains.
